



## REGULATION

### CHRISTMAS VIRTUAL RACE 2020

#### DECEMBER 19 to 31

*A 10 or 3 km Virtual Race, recreational motor event, open to all*

**Prime Time Promotions, in collaboration with** Corsa dei Santi A.S.D., promotes the "Christmas - Virtual Race 2020" recreational motor event, open to all.

The race will take place in virtual form, therefore each athlete will cover the distance (3 or 10 km depending on the race course he chooses) individually and at the time that suits him the best from the 19th to the 31st of December. The athletes' performances will be recorded thanks to the CVRace app, which must be activated for the entire duration of the race, with active geolocation in order to allow the system to memorise race times.

Each participant will be able to monitor the distance covered and the time taken even during the race and at the end of it, it will be possible to view the final ranking directly from the application.

The proceeds of the registrations for the event will be entirely donated to the charitable projects carried out by Missioni Don Bosco and Schoals Occurrentes, organisations currently engaged in missionary activities to address the serious economic and social consequences deriving from the Covid-19 pandemic.

#### **General information:**

- The participation is open to all.
- Registrations are possible only online, directly from the TDS circuit on the ENTERNOW.IT website, by and no later than 8:00 pm of Thursday, December 31st 2020 (depending on race-bibs' availability).
- The registration is individual. You can register either by using your own username or, for those who do not have one, by creating a new one on the tds.sport or enternow.it website.

The same username will be used later to access the GPS tracking app

- A few days before the race, athletes will receive all necessary information to download and install the GPS tracking app on their Android or IOS device, as well as the instructions for proper use.

- It is possible to start competing at the virtual race anytime from 07:00 am on December 19th 2020 up until 8:00 pm on December 31st 2020.

- During the race, the athlete will have to run carrying along the smartphone on which the GPS tracking app has been installed. During the start time, the athlete will need to activate the GPS tracking and then start running. The movements will be tracked in real time and sent to TDS. At the end of the predetermined distance, the app will automatically stop the race time.

**N.B. since it is a tracking app, membership must be voluntary and explicit, therefore each athlete should accept and sign a privacy disclaimer (sign and flag when downloading the App).**



- 10 or 3 km route only outdoors (not on a treadmill) respecting the rules imposed by current legislation and respecting the rules laid down by the Street Code regarding pedestrians.
- maximum time 1h30

#### **Subscription fee:**

- Virtual race-bib only: € 8.00.
- Virtual race-bib + technical shirt, home delivered, while stocks last: € 20.

#### **Included Services:**

- publication of subscribers on the tds.sport site and the possibility to verify their registration for the event
- sending registration confirmation emails, communication of timetables and other useful information
- sending the race-bib in digital format to the athlete;
- communication of useful information for the conduct of the race to all athletes, along with instructions on how to use the tracking app
- the possibility for audience to follow their friends and / or relatives from home in real time, virtually locating them on the official race path;
- the publication of the results in real time (always taking into account the starting range of the athletes), with splits planned at every km;
- sending an email to the athletes with their results;
- at the end of the event, the publication of a personalised participation diploma

**Further specification:** this is an individual recreational motor event, authorised by the current Covid-19 regulations. By registering for the virtual race, participants declare that they know and accept these regulations; that they relieve and exonerate the organisers from any civil and criminal liability, even objective, deriving from participation in the aforementioned initiative; that they exonerate the organisers from any responsibility for injuries suffered as a result of accidents caused to oneself or to third parties and for pains related to carrying out the race.
